**RE: AUTHORIZATION OF TRANSFER OF CREDITS OR UNITS FOR  
THE PROJECT VCS 2676 COMMUNITY CARBON EFFICIENT  
COOKING PROGRAMME -TANZANIA 1**

Please refer to the above mentioned subject.

2. The United Republic of Tanzania is a party to the United Nations Conventions on Climate Change (UNFCCC), Kyoto Protocol, and the Paris Agreement.
3. The Vice President's Office (VPO) as National Designated Authority (NDA) and National Focal Point is mandated to oversee Tanzania's participation in the implementation of Article 6.2 of the Paris Agreement.
4. The Vice President's Office (VPO) has reviewed and considered the recommendations of the National Carbon Project Assessment Technical Committee with regard to the project VCS 2676 Community Carbon Efficient Cooking Programme-Tanzania 1, listed under Verra Standard ID 3242 (the Project) and hereby authorize the sale or other disposition, of 271,630 tCO<sub>2</sub>e, including any rights, title or interests thereto, from implementing the Project by Community Carbon pursuant to Article 6.2 of the Paris Agreement. This authorization is for the following vintages:

1. The VPO hereby authorize the mitigation outcomes generated from this project for use under Other International Mitigation Purposes (OIMP), specifically for the International Civil Aviation Organization's Carbon Offsetting and Reduction Scheme for International Aviation (CORSA).
2. The VPO hereby recognize the 'Community Carbon Efficient Cooking Programme- Tanzania 1 with Community Carbon as the applicable cooperative approach for this project
3. The National Registry and any other registry recommended and agreed by both parties shall be the registry of record for tracking, issuing, and transferring ITMOs from the Authorized activity.
4. The authorization of the Project's emission reductions and removals under this Letter of Authorization shall constitute the "First Transfer" of the Authorized ITMOs and credits for purposes of Article 6.2 of the Paris Agreement and its associated modalities and procedures.
5. The VPO will apply corresponding adjustments to the Authorized Credits upon authorization and will not use the Authorized Credits to implement and achieve Tanzania's NDC.
6. This Authorization is limited to ITMOs issued in respect of emission reductions that occur in the NDC period from 2021 to 2030.
7. Any change or revocation of this authorization shall only occur in the circumstances outlined in Section 31 of The Environmental Management (Control and Management of Carbon Trading) Regulations, 2022 and its 2023 amendments: Such changes shall follow a transparent process agreed by the Parties and be managed in a manner that prevents double counting of mitigation outcomes.
